



# SOLUTION AND TECHNIQUES

## MAKE USE OF SPELLCHECKING OR AUTO-COMPLETE OF TERMS, AS USER TYPES THE **KEYBOARD.**

e.g.: IF THE USER TYPES "PROF" OR EVEN "PORF" THE SYSTEM IMMEDIATELY CAN PROPOSE "PROFESSOR", "PROFESSIONAL", "PROFISSÃO... THE SUGGESTIONS ARE MADE BASED ON THE PERCEPTION OF USED CONTEXT AND THE PAST USAGE OF THE SYSTEM BY THE APPLICATION OF ALGORITHMS FOR SESSION ANALYSIS AND CLICK MODELS

# SOLUTION AND TECHNIQUES

CLUSTER OF RESULTS BY SUBJECT AND/OR RANK THEM ACCORDING TO THEIR PAST POPULARITY. USE UNSUPERVISED ANALYSIS OF CONCEPT ASSOCIATIONS (FORMAL CONCEPT ANALYSIS) AND ORDER THE DOCUMENTS ACCORDING TO THEIR DYNAMIC POPULARITY, WHICH CAN BE DEFINED BY THE NUMBER OF PAST ACCESSES.

# SOLUTION AND TECHNIQUES

HIGHLIGHT SEARCH TERMS, POINT SIMILAR DOCUMENTS, RECOMMEND HELP OF THESAURI **OR CLASSIFICATION SYSTEMS. APPLY SEMI-**AUTOMATED CLASSIFICATION WITH, FOR EXAMPLE, THE EUROVOC THESAURUS, RELYING ON A MACHINE LEARNING CLASSIFIER.


THE GOAL

# SUPPORT THE USER EXPLORING OF THE COLLECTION (SERENDIPITY...)



MANY DOCUMENTS ARE RELATED, SO AN ONTOLOGY OF THESE RELATIONS AND A POWERFUL VISUAL INTERACTION CAN HELP USERS EXPLORING THE COLLECTION, ENRICHING THE METADATA WITH AUTOMATED ENTITY RECOGNITION TECHNIQUES.







## DRE.PT CODE THE LAW - HELPING CONSUMER RIGHTS

**PROBLEMS** 

Difficulties to interpreter consumer rights, to articulate with another legislative documents and receive answers.

SOLUTION AND TECHNIQUES

Go through the interpretation of commercial or operational rules and code them. Document classification techniques/processes. Pre-processing a large number of documents with tokenization, stop words removal, stemming, term identification, synonyms handling, word validation, pruning. Calculation functions intended in the project of rules. Simulator will respond to the citizen about his own situation and his/her rights and obligations.
