- ✓ Different approaches to law and revolution methodology and conceptual analysis
- ✓ Secession and revolutionary territoriality politics (including Brexit)
- ✓ Inequality and its revolutionary impact on constitutional law

We will highly appreciate theoretical research containing provocative and innovative theses proven by solid scientific arguments. Papers with comparative and interdisciplinary approach are highly welcomed. The aim is to have contributions which will provoke discussion and will be considered as contributions in the contemporary scholarly debate in Europe. However, well-elaborated case-studies and research with practical importance will also be accepted.

Selected papers will be published with prestigious publishers after double blind peer review process.

The conference language is **English**. The papers should also be written in **English**. Further requirements for the papers will be communicated to the approved participants of the Sofia Legal Science Week.

There is **no conference fee**. All travelling and accommodation expenses should be borne by the participants themselves. The participants from our "Erasmus" partner universities may use the "Erasmus" teaching grant for financing their participation.
